



- 2.2. PREVENT ANY PORTION OF THE FLOOR, WALLS, ROOF OR END FACES OF EXCAVATIONS FROM SLIPPING OR FALLING, OR BEING FORCED THROUGH JOINTS AND OPEN SPACES IN THE GROUND SUPPORT SYSTEM.
- 2.3. MAINTAIN THE GROUND SUPPORT SYSTEM IN A SATISFACTORY CONDITION UNTIL THE COMPLETION OF THE SECTION OF THE WORK IN WHICH IT IS LOCATED.
